

AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR HERITAGE COVE II

WHEREAS, the Declaration is recorded in Official Records Book 3335, Page 4258 through 4315, and subsequently amended on March 12, 2001 in Official Records Book 3375 at Page 0982; and as later amended on January 15, 2002 in Official Records Book 3559 at Pages 2429-2432; Public Records of Lee County, Florida; and

WHEREAS, pursuant to Section 13.3 of this Declaration, the Declarant reserved, in his sole discretion, the right to unilaterally modify or amend the Declaration and its exhibits to bring additional Lots within the Properties submitted and governed by this Declaration; and

WHEREAS, the Declarant is desirous of amending the Declaration of Covenants, Conditions and Restrictions for Heritage Cove II, pursuant to its reserved right to amend;

NOW, THEREFORE, the Declarant makes the following amendment to this Declaration:

1. The lots described in Exhibit "A" attached hereto shall be added to those lots previously submitted to the original Declaration and shall be considered additional lots submitted to and subjected to this Declaration.
