PROPOSED AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR TERRACE VI AT HERITAGE COVE, A CONDOMINIUM

The Declaration of Condominium for Terrace VI at Heritage Cove, a Condominium shall be amended, as follows otherwise, all other provisions shall remain the same:

(New language is underlined)

- 1. Section 14 to the Declaration shall be amended as follows:
- **14. Guest Occupancy.** A "guest" is defined as a person who enters upon the condominium property at the invitation of a unit owner, (or their respective families) for the purpose of visiting the unit owner (or his respective family), or utilizing the Condominium Property. Guests are not permitted to bring a pet of any kind to the Condominium <u>unless the unit owner is in residence.</u> Use or visitation without consideration (payment) distinguishes as a guest usage from tenancy.
