AMENDMENT TO DECLARATION OF HOMEOWNERS ASSOCIATION VILLAS II AT HERITAGE COVE

WE HEREBY CERTIFY THAT, the amendment to the Declaration set out herein and made a part hereof, passed in accordance with the necessary affirmative votes to pass the amendment as required; and that as a result of the foregoing, and proper notice having been given, said amendment has been duly adopted.

Section 11.3, of the Declaration entitled "Leasing" shall be amended as follows:

<u>Leasing.</u> Villas may be leased, with the minimum allowable lease period being thirty (30) ninety (90) consecutive days. No lease may begin sooner than thirty (30) ninety (90) after the first day of occupancy under the last previous lease. All leases are subject to the following restrictions and conditions:

- (A) The lease must be written, and a fully executed copy must be provided to the Association not less than fifteen (15) days before the beginning of the lease term, together with such other information about the tenants as the Board may reasonably require.
- (B) No lease may be for a period of less that thirty (30) ninety (90) consecutive days.
- (C) No more than six (6) overnight occupants are allowed in a leased Villa.
- (D) No subleasing or assignment of lease rights is allowed.
- (E) No one but the lessee and the lessee's s pouse if a ny, and their unmarried children who live with their parents, may occupy the unit during a lease.

In all other respects, the Declaration, as previously recorded, remains in full force and effect and unchanged.
