MATERIALS:

- (2) Two 15 (ft) pieces ½ inch nylon rope. Melt ends to stop fraying. Nylon rope can be purchased at Home Depot
- Four (4) Stainless steel wood screws
- Gibraltar Green Mailbox Elite Medium Size Galvanized Steel Post-Mount Mailbox.
 Dimensions: 6.92 in. W x 8.87 in. H x 20.05 in. D. If needed, Gibraltar Elite Medium mailbox is item # E1100G00 and is available on Amazon
- Dynasty Marquee Behr Cavalry brown N220-7D Satin Finish exterior paint for posts.
- Dynasty Marquee Behr Messa Taupe PPU5-14M Satin Finish exterior paint for address board. Behr paints are available at Home Depot
- Black paint for house numbers
- New posts if needed 3 inch or 3-3/4 inch dia. by 8ft (can be purchased at Home Depot or any local fence company)

PROCESS:

- Remove old mailbox
- Remove old rope
- Clean or power wash posts
- Let posts and address board dry for 24 hours
- Repaint house numbers with black paint on both sides
- Paint posts and mailbox platform with Cavalry brown paint
- · Paint address board with Messa taupe paint
- Reattach mailbox
- Wrap mailbox posts 9 times with ½ inch nylon rope. This will require (2) 15 ft sections
 of nylon rope. Separate top and bottom wrap of rope on posts by 13 inches

MAILBOX MAINTENANCE:

To Polish / To Paint / To Replace

- Polish: It is recommended to use a "cleaning" wax similar to Meguiar's Cleaning Wax
- Paint: Color match using spray Rust-oleum Professional High Performance Enamel "Hunter Green 7538"
- Replace: Gibraltar Mailboxes Elite Medium Size Galvanized Steel Post-Mount Mailbox in Green. Dimensions: 6.92 in. W x 8.87 in. H x 20.05 in. D.
- Gibraltar Elite Medium mailbox is item # E1100G00 is available on Amazon

It is recommended that owners maintain their mailbox every other year - at minimum
